The Bagong Bayani Awarding Ceremony will be held in December 2013 at the Malacañan Palace, with President Benigno S. Aquino III present.

The Search has been jointly opened by the Bagong Bayani Foundation, Inc. (BBFI) in coordination with the Philippine Overseas Employment Association (POEA), Overseas Workers Administration (OWWA) and the private sector.
